Design Review TIR/EXP

There have not been any design changes since the last meeting on March 10,2021. SST reviewed the second level plan. There was discussion around the sliding doors to block out sound but they were taken off the plan due to the budget.

Vernon Taylor and Sheila Maddison-Alick decided that the glass window frame between the Seminar Room and Reading Recovery be 6 ft. There is also a display space to be used to display artwork and creations for Pre-Primary-Grade 6.

The access to the boiler room will be from outside for this school. There was some discussion about having inside access but other newer schools don't have inside access. The reason is so that tradespersons do not need to be going into the schools to access the boiler room.

Schools plus is a space, for our vulnerable children. This is a space where appointments come to the students who would not normally have access to certain services. This is an important space to have for our students. Hubs are not going into the schools anymore.

There was some discussion on possibly making the school bigger but it has ramifications and will slow down construction as it is hoped to be started in the fall.

There was also discussion on weather the bleachers were included in the previous cost – minutes were confirmed and bleachers *are included* with the enhanced gymnasium.
